NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce a 20 MPH speed limit on Dappers Lane in Angmering throughout its entire length. This is a revised version of a scheme originally proposed in November 2024.

(Angmering: Dappers Lane) (20 MPH Speed Limit) Order 2025

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce a 20 MPH speed limit on Dappers Lane in Angmering throughout its entire length.

A Traffic Regulation Order was advertised in November 2024 proposing a 20 MPH speed limit on Dappers Lane from its junction with Arundel Road southwards to the existing 30 MPH speed limit near the junction with Merryfield Crescent. During the consultation to this proposal objections were received, all of which requested that the new 20 MPH speed limit be longer than proposed.

The initial design reflected a cap on the budget available for schemes of this type and covered the longest length of road possible under this constraint. However, since the scheme was originally designed, the budget cap for such schemes has been revised and on review it is now considered that the speed limit could be applied to the whole road.

The original scheme was proposed in response to a community Traffic Regulation Order application submitted to the Council which requested a reduced speed limit at the northern end of Dappers Lane due to the narrow nature of the road and its use by vulnerable road users such as cyclists, walkers and equestrians. The revised scheme is proposed for the same reasons but is extended to cover the whole length of Dappers Lane to address responses to the previous consultation. These cited safety issues caused by the speed of traffic on other lengths of the road and raised concerns about inconsistency with 20 MPH speed limits in the rest of Angmering.

The revised proposal has been re-assessed against the WSCC speed limit policy which confirmed that the road qualifies for a 20 MPH speed limit as requested.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road.

The attached drawing, numbered ARN2304 shows the length of road affected by the proposed order.

WEST SUSSEX COUNTY COUNCIL
(ANGMERING: DAPPERS LANE) (20 MPH SPEED LIMIT) ORDER 2025

West Sussex County Council in exercise of their powers under Section 84 (1) a of the Road Traffic Regulation Act 1984 ("the Act"), and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the ***** day of ***** and may be cited as "West Sussex County Council (Angmering: Dappers Lane) (20 MPH Speed Limit) Order 2025"
2. The part of the Order specified in the First Schedule to this Order is hereby revoked.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour in the length of road specified in the Second Schedule to this Order.
4. Nothing in Paragraph 2 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the timebeing subject to the orders of a member of the armed forces of the Crown on an occasion when –
 - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
 - (b) the vehicle is being driven-
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds.


