

Trade Union Facility Time Reporting – 2024/25

(Facility Time Publication Requirements) Regulations 2017 require WSCC to collect and publish, on an annual basis, a range of data in relation to their usage and spend of Trade Union facility time in respect of their employees who are Trade Union representatives.

WSCC must comply with this reporting requirement separately in relation to its central function employees; its education function employees; and its fire and rescue function employees.
