NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) on both sides of the western end of Old Shoreham Road in Lancing at the entrance to a residential property development being built on land east of the Grinstead Lane Roundabout. The Order also prohibits waiting at any time at the junction of Old Shoreham Road with Manor Way.

(Lancing: Old Shoreham Road & Manor Way Amendment) Order 2025

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) on both sides of the western end of Old Shoreham Road in Lancing. The Order also prohibits waiting at any time at the junction of Old Shoreham Road with Manor Way.

Planning permission has been granted for the construction of a new residential property development on land east of the Grinstead Lane Roundabout. This development will be accessed from a new junction joining the western end of Old Shoreham Road. The proposed Order installs double yellow lines at this new junction to prevent parked vehicles obstructing access to the new development, and to maintain safety at the junction.

The opportunity is also being taken to install double yellow lines at the nearby junction of Manor Way with Old Shoreham Road. This restriction is also proposed to prevent parked vehicles obstructing sightlines and safe access into Manor Way.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawings, numbered TQ1805NES and TQ1805SEN show the lengths of roads affected by the proposed order.




