NOTICE is hereby given that West Sussex County Council propose to make a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on the eastern side of Brighton Road north and south of the junction with Hogshill Gardens.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on the eastern side of Brighton Road north and south of the junction with Hogshill Gardens.

West Sussex County Council received a request to improve pedestrian crossing facilities on Brighton Road, Crawley close to the entrance of Hogshill Gardens.

When undertaking onsite inspections to confirm a suitable location for a crossing point it was felt that whilst an uncontrolled crossing point could be provided north of Hogshill Gardens, to do so would require some waiting restrictions also being installed. The waiting restrictions are necessary so that parked vehicles will not obscure visibility for pedestrians using the new crossing facility.

To provide sufficient visibility for those using the crossing to do so safely, it is proposed to introduce lengths of double yellow lines on the eastern side of Brighton Road north and south of the new crossing point.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenity of the area through which the road runs.






