(Seaview Road Amendment) Order 2025

<u>Statement of Reasons</u> for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce double yellow lines at the junction of Seaview Road with Bath Road in Worthing.

The council has received a request for restrictions at the affected junction to address problems caused by vehicles parking too close to the junction. These vehicles hazardously restrict visibility for traffic and prevent vehicles travelling in opposite from passing each other.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawing, numbered TQ1302SES shows the lengths of roads affected by the proposed order.




