SOUTHBOURNE - COOKS LANE TRAFFIC CALMING MEASURES

NOTICE is hereby given that in exercise of their powers West Sussex County Council propose to:-

- (i) under the Road Traffic Regulation Act 1984, make a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at any time (double yellow lines) on the west side of Stein Road from the railway crossing northwards for 36metres; and,
- (ii) under the provisions of the Highways (Road Humps Regulations) 1999 and Highways Act 1980, install a raised table on Cooks Lane at the junction with Stein Road.

The raised table will be constructed from asphalt being 65 mm above the existing road surface and crossing the entire width of the carriageway.

The overall length of the table will extend 11.65 metres in Cooks Lane with ramp gradients of 1:15.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER & INSTALL THE RAISED TABLE

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, proposes to make a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at any time (double yellow lines) on the west side of Stein Road from the railway crossing northwards for 36metres; and,

(ii) under the provisions of the Highways (Road Humps Regulations) 1999 and Highways Act 1980, proposes to install a raised table on Cooks Lane at the junction with Stein Road.

The raised table will be constructed from asphalt being 65 mm above the existing road surface and crossing the entire width of the carriageway.

The overall length of the table will extend 11.65 metres in Cooks Lane with ramp gradients of 1:15.

Concerns have been raised by the Parish Council about parked vehicles creating congestion and concerns for pedestrians and cyclists due to high traffic speeds on Stein Road.

To address these issues it is proposed to introduce a length of double yellow lines north of the railway crossing on the west side of Stein Road where vehicles parked in too close proximity to the crossing are causing an obstruction to those vehicles waiting at the railway crossing gates.

It is also proposed to install a raised table at the junction of Cooks Lane and Stein Road which aims to reduce the speed of traffic entering and exiting Cooks Lane and improve crossing safety for pedestrians and road safety for cyclists.

The Order and raised table are proposed to avoid danger to persons or other traffic using the roads or for preventing the likelihood of any such danger arising and to facilitate the passage on the road of any class of traffic (including pedestrians).

Plan Nos. SU7605NEN and SU7606SES and Drawing No. UK288033-WSP-HGN-SRS-DR-CH-0101 show the length of road that is the subject of the proposed Order and the location of the raised table.








