NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) on the southern side of Woodlands Road in Haywards Heath, opposite its junction with Mayflower Road. The Order also makes a short extension to existing double yellow lines on the eastern side of Mayflower Road at the same junction.

**Statement of Reasons for Proposing to Make the Order**

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce double yellow lines on the southern side of Woodlands Road in Haywards Heath, opposite its junction with Mayflower Road. The Order also makes a short extension to existing double yellow lines on the eastern side of Mayflower Road at the same junction.

The new restrictions are proposed following a receipt of a community TRO Request. This raised concerns that the junction of Woodlands Road with Mayflower Road frequently becomes hazardous and is obstructed by vehicles parking too close to the junction, particularly at school pick up and drop off times.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawing, numbered TQ3323NEN shows the lengths of roads affected by the proposed order.

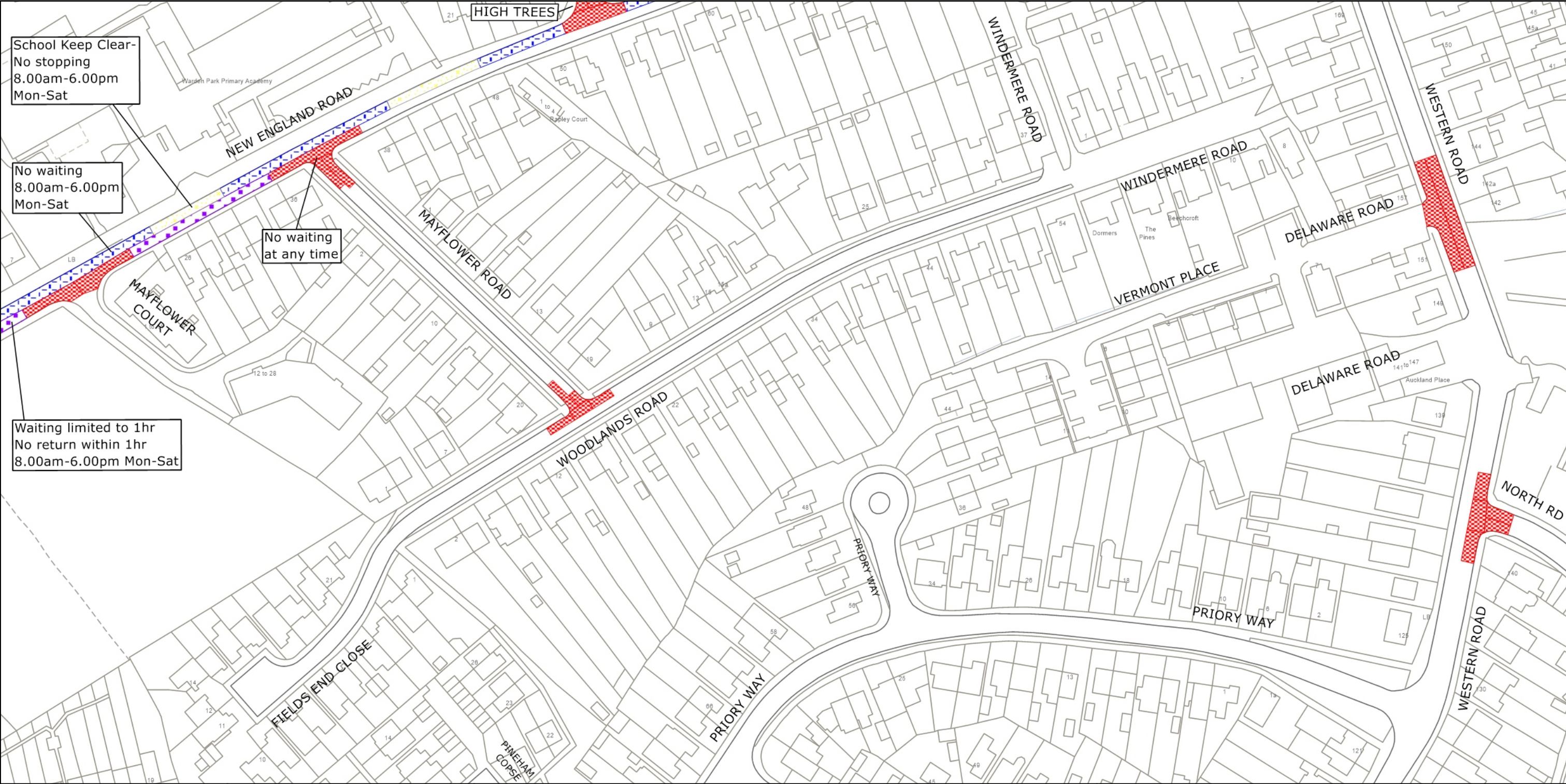
