**(Shoreham-By-Sea: Swiss Gardens Amendment) Order 2026**

NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce new waiting restrictions on Swiss Gardens in Shoreham-By-Sea.

The proposed restrictions include prohibiting waiting at any time (double yellow lines) on lengths of the northern side of the road. It is also proposed to prohibit waiting from 9am to 5pm Mon-Fri on various lengths of both sides of the road, and to formalise an existing bay for disabled persons' blue badge holders on the southern side of the road.

**(Shoreham-By-Sea: Swiss Gardens Amendment) Order 2026**

**Statement of Reasons for Proposing to Make the Order**

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce new waiting restrictions on Swiss Gardens in Shoreham-By-Sea.

The proposed restrictions include prohibiting waiting at any time (double yellow lines) on lengths of the northern side of the road. It is also proposed to prohibit waiting from 9am to 5pm Mon-Fri on various lengths of both sides of the road, and to formalise an existing bay for disabled persons' blue badge holders on the southern side of the road.

A School Street scheme has been introduced on Swiss Gardens to improve safety for children travelling to Swiss Gardens Primary School. The first phase of this scheme included the introduction of a restriction prohibiting driving on the road at school pick up and drop off times, with access maintained for residents. The second phase of the scheme will improve signage, improve footways and introduce new uncontrolled pedestrian crossing points. To prevent these new features being obstructed by parked cars and improve the operation of the school street, new waiting restrictions are proposed.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road.

The attached drawings, numbered TQ2105NWS and TQ2105SWN show the lengths of road affected by the proposed order.






