NOTICE is hereby given that West Sussex County Council proposes to introduce a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce:-

- (i) a 30mph speed limit on lengths of Bohemia Hollow and West Harting Road; and
- (ii) a 20mph speed limit on a length of Mill Lane; and
- (iii) extend the 20mph speed limit on the B2146 by 60 metres to a point 185 metres west of The Street

These proposals are additions to the 20mph speed reduction scheme for South Harting village that was advertised in summer 2024 under reference TRO/CHI8013/RC.

Full details of the proposals in this Notice can be viewed on our website www.westsussex.gov.uk/tro. The website includes a response form for comments or objections.

Statement of Reasons For Proposing To Make The Order

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order, the effect of which will be to introduce:-

- (i) a 30mph speed limit on lengths of Bohemia Hollow and West Harting Road; and
- (ii) a 20mph speed limit on a length of Mill Lane; and
- (iii) extend the 20mph speed limit on the B2146 by 60 metres to a point 185 metres west of The Street

In summer 2024 a consultation was undertaken on a community highways scheme that aims to improve road user safety for residents and visitors to Harting village and improve access to the two main recreational areas. The proposed speed reduction aims to make more journeys within the village walkable and provide safer connectivity on foot or by bike to the South Downs Way and public rights of way around the village.

The scheme TRO/CHI8013/RC proposed to introduce:-

- (i) a 20mph speed limit on lengths of the B2146 Park Road, South Gardens and The Street, Culvers, Elsted Road, The Hop Garden, New Lane, North Lane, Pease Croft, South Acre, Tipper Lane and Warren Side and
- (ii) a 30mph speed limit on lengths of the B2141 Harting Hill and B2146, and
- (iii) a 40mph speed limit on a length of the B2146

The final decision on the scheme has not been made but, as a direct result of consultation feedback, the opportunity is being taken to consult on some proposed additions to that scheme.

A 20mph speed limit is proposed on a length of Mill Lane and a 30mph speed limit is proposed on lengths of Bohemia Hollow and West Harting Road. The 30mph speed limit on Bohemia Hollow will apply from West Harting Road northwards for a distance of 159 metres to the property boundaries of Pays Meadow/The Orchard. The 30mph speed limit on West Harting Road will apply from North Lane westwards for a distance of 288 metres to the access of Poppets Barn. It is also proposed to extend the 20mph on the B2146 by 60 metres to a point 185 metres west of The Street. This is so the layby is within the 20mph speed limit.

This Order is proposed so as to reduce danger to persons or other traffic using the road or to minimise the likelihood of any such danger arising and for facilitating the safe passage of any class of traffic (including pedestrians).

WEST SUSSEX COUNTY COUNCIL

West Sussex County Council in exercise of their powers under Sections 82 (2), 83 (2) and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the X day of X 202* and may be cited as "West Sussex County Council (Harting: B2146, & Various Roads) (20mph, 30mph and 40mph Speed Limit) (No. 2) Order 202*"
2. The Order in the First Schedule to this Order are hereby revoked.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour on the length of road specified in the Second Schedule to this Order.
4. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour on the length of road specified in the Third Schedule to this Order.
5. No person shall cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour on the length of road specified in the Fourth Schedule to this Order.
6. Nothing in Paragraphs 3, 4 and 5 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown on an occasion when –
 - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
 - (b) the vehicle is being driven-
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds.


