NOTICE is hereby given that West Sussex County Council proposes to make two permanent Traffic regulation Orders under the provisions of the Road Traffic Regulation Act 1984. The effect of the first Order will be to prohibit any vehicle other than a bus operating a local service or a pedal cycle from driving on Brown Meadow Way/Hayley Road in Lancing from its junction with Shadwells Road eastwards for 20 metres.

The second Order will prohibit waiting at any time (introduce double yellow lines) on both sides of Brown Meadow Way/ Hayley Road at its junction with Shadwells Road, and on various lengths of road at the junction formed by Brown Meadow Way, Brimstone Road and Goshawk Road.

Full details of the proposals in this notice can be viewed on the Traffic Regulation Order page of the <u>West Sussex County Council website</u>. The website includes a response form for any comments or objections.

#### **Statement of Reasons for Proposing to Make the Orders**

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit any vehicle other than a bus operating a local service or a pedal cycle from driving on Brown Meadow Way/Hayley Road in Lancing from its junction with Shadwells Road eastwards for 20 metres.

It is also proposed to make a permanent Traffic Regulation Order that will introduce double yellow lines on both sides of Brown Meadow Way/ Hayley Road at its junction with Shadwells Road, and on various lengths of road at the junction formed by Brown Meadow Way, Brimstone Road and Goshawk Road.

A large property development named New Monks Park is being constructed on land east of Shadwells Road in Lancing. General access for vehicles is provided via new junctions onto the A27. A junction serving the new development has also been added at Hayley Road, with the sole purpose of allowing existing local bus services to be extended into New Monks Park.

To prevent this junction being used for general access to New Monks Park it is proposed to install a 'bus gate' at the new junction on Hayley Road. This is considered necessary because the pre-existing residential roads are not of a suitable layout to accommodate the likely increase in vehicle movements that would be caused if the junction was left unrestricted.

The proposed new waiting restrictions are intended to ensure parked vehicles do not obstruct buses operating the new bus route as they pass through the affected junctions.

The new order is therefore proposed to preserve or improve the amenities of the area through which the road runs and to facilitate the passage of traffic.

The attached drawing, numbered 109 shows the layout of the proposed bus gate feature and drawings numbered TQ1805SEN and 1905SWN show the length of road affected by the proposed waiting restrictions.

# WEST SUSSEX COUTY COUNCIL (LANCING: BROWN MEADOW WAY/HAYLEY ROAD) (PROHIBITION OF DRIVING) ORDER 2024

West Sussex County Council in exercise of their powers under Sections 1 (1) 2 (1) and (2), 4 (2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

## PART 1 GENERAL

- 1. This Order shall come into operation on the \*\*\*\*\*\*\* day of \*\*\*\*\*\*\* 2024 and may be cited as "West Sussex County Council (Lancing: Brown Meadow Way/Hayley Road) (Prohibition of Driving) Order 2024" hereinafter called "this Order".
- 2. The prohibitions imposed by this Order shall be in addition to and not in derogation from any restriction imposed by any regulations made or having effect as if made under the Act or by or under an enactment.
- 3. Interpretation

In this Order:

"public service vehicle" has the same meaning as in section 1 of the Public Passenger Vehicles Act as amended.

## Prohibition of Driving Provisions

- 3. Save as provided in Article 4, no person shall cause or permit any vehicle to be driven on the length of road specified in the Schedule of this Order.
- 4. Nothing in Article 3 shall apply in respect of :-
  - (a) A Public Service Vehicle being driven in the operation of a local bus service; or
  - (b) a pedal cycle; or
  - (c) a Police, Ambulance Service or Fire Brigade vehicle being used in the event of an emergency.






