# (Bersted and Aldingbourne) (Shripney Road (A29): Restricted Road and 30 MPH Speed Limit) (Shripney Lane: 20 MPH Speed Limit) and (Various Roads: Speed Limit Consolidation) Order 2025

NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce a 30 MPH speed limit on Shripney Road (A29) in Bersted from a point 200m south of its junction with Shripney Lane, northwards to a point 270m south of its junction with Sack Lane.

The Order also introduces a 20 MPH Speed limit on Shripney Lane in Bersted from its junction with Shripney Road (A29) westwards for 660m.

Full details of the proposals in this notice can be viewed on the Traffic Regulation Order page of the <u>West Sussex County Council website</u>. The website includes a response form for any comments or objections.

### **Statement of Reasons for Proposing to Make the Order**

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce a 30 MPH speed limit on Shripney Road (A29) in Bersted from a point 200m south of its junction with Shripney Lane, northwards to a point 270m south of its junction with Sack Lane.

The Order also introduces a 20 MPH Speed limit on Shripney Lane in Bersted from its junction with Shripney Road (A29) westwards for 660m.

The proposed speed limits are part of a scheme to improve pedestrian safety through the village of Shripney. The 20 MPH speed limit on Shripney Lane will improve safety for vulnerable road users such as walkers on a road with no footways and the 30 MPH speed limit on Shripney Road (A29) will improve safety for pedestrians crossing the road.

The Order also consolidates existing speed limits on Shripney Road (A29) in Aldingbourne and Bersted to ensure the adjoining speed limits are correctly enacted following the introduction of the new 30 MPH speed limit through Shripney. The opportunity is also being taken to consolidate the existing 40 MPH speed limit on Rowan Way for housekeeping purposes.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to preserve the character of the road where it is especially suitable for persons on horseback or on foot.

The attached drawing, numbered ARN8015 shows the lengths of roads affected by the proposed order.

# WEST SUSSEX COUNTY COUNCIL (BERSTED AND ALDINGBOURNE) (SHRIPNEY ROAD (A29): RESTRICTED ROAD AND 30 MPH SPEED LIMIT) (SHRIPNEY LANE: 20 MPH SPEED LIMIT) AND (VARIOUS ROADS: SPEED LIMIT CONSOLIDATION) ORDER 2025

West Sussex County Council in exercise of their powers under Section 84 (1) a of the Road Traffic Regulation Act 1984 ("the Act"), and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

- This Order shall come into operation on the \*\*\*\*\* day of \*\*\*\*\*\*\* and may be cited as "West Sussex County Council (Bersted and Aldingbourne) (Shripney Road (A29): Restricted Road and 30 MPH Speed Limit) (Shripney Lane: 20 MPH Speed Limit) and (Various Roads: Speed Limit Consolidation) Order 2025"
- 2. The Parts of Orders Specified in the First Schedule to this Order are hereby revoked.
- 3. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles pr hour in the length of road specified in the Second Schedule to this Order.
- 4. The length of road specified in the Third Schedule to this Order shall be a restricted road for the purpose of Section 82 of the Act.
- 5. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of road specified in the Fourth Schedule to this Order.
- 6. No person shall cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of road specified in the Fifth Schedule to this Order.
- 7. No person shall cause or permit any vehicle to proceed at a speed exceeding 50 miles per hour in the length of road specified in the Sixth Schedule to this Order.
- 8. Nothing in Paragraphs 3, 4, 5, 6 and 7 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the timebeing subject to the orders of a member of the armed forces of the Crown on an occasion when
  - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
  - (b) the vehicle is being driven-
    - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
    - (ii) for the purpose of training a person in driving vehicles at high speeds.
