- (ii) extend the lengths of double yellow lines on Durbans Road north and south of its junction with Kirdford Road.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to:-

- (i) introduce lengths of prohibition of waiting at any time (double yellow lines) in and around the junction of Butts Meadow and Butts Meadow Access Road; and
- (ii) extend the lengths of double yellow lines on Durbans Road north and south of its junction with Kirdford Road.

Wisborough Green village benefits from a number of well used facilities including a Primary School, Public House and Sports club creating additional pressure on the limited on-street parking.

The Parish Council submitted a request on behalf of the local community for some parking restrictions to alleviate issues caused by inconsiderate parking in specific locations to ensure the safety and wellbeing of both the local community and visitors.

Parking on Butts Meadow adjacent to the play area and in too close proximity to the junction obscures visibility and forces drivers to use the wrong side of the road, creating a hazardous situation. Double yellow lines are proposed to prohibit parking on the junction and improve visibility for all road users.

It is proposed to extend the existing double yellow lines on Durbans Road north and south of the junction with Kirdford Road. The extension northwards on the west side of Durbans Road will improve visibility for vehicles exiting Kirdford Road. The extension southwards to the laybys on both sides of the road will improve visibility for motorists and for pedestrians crossing Durbans Road.

The Order is proposed to facilitate the passage on the road of any class of traffic (including pedestrians) and for preserving or improving the amenities of the area through which the road runs.

2. The "West Sussex County Council (Chichester District) (Parking Places and Traffic Regulation) (Consolidation) Order 2010" is hereby amended by the deletion from it of the plan in the First Schedule to this Order and the substitution of the plan attached in the Second Schedule to this Order.
