NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to formalise an existing bus stop on the western side of Old Shoreham Road in Shoreham-By-Sea approximately 300m south of its junction with Upper Shoreham Road. The restriction applied to the bus stop will be to prohibit stopping by any vehicles other than buses between 7am and 7pm on any day.

The Order also prohibits waiting at any time (introduces double yellow lines) either side of the formalised bus stop.

Full details of the proposals in this notice can be viewed on the Traffic Regulation Order page of the <u>West Sussex County Council website</u>. The website includes a response form for any comments or objections.

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will formalise an existing bus stop on the western side of Old Shoreham Road in Shoreham-By-Sea approximately 300m south of its junction with Upper Shoreham Road. The restriction applied to the bus stop will be to prohibit stopping by any vehicles other than buses between 7am and 7pm on any day.

The Order also prohibits waiting at any time (introduces double yellow lines) either side of the formalised bus stop.

West Sussex County Council is conducting a review of bus stop infrastructure with the aim of improving pedestrian access to public transport. On Old Shoreham Road, it is considered that formalising the affected bus stop will allow buses to pull up at the kerb at a location where this is currently often prevented by parked cars. This will improve safety for passengers boarding the bus and reduce instances where traffic on Old Shoreham Road is obstructed by buses having to stop in the running carriageway of the road.

Short lengths of double yellow line are proposed to either side of the bus stop. This will ensure the bus can enter and exit the bus stop without obstruction and will also improve visibility for pedestrians crossing the road.

The new order is therefore proposed to preserve or improve the amenities of the area through which the road runs and to facilitate the passage of traffic.

The attached drawing, numbered TQ2005NES shows the length of road affected by the proposed order.




