NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to install a loading bay for any vehicle at any time on the western side of Clarence Road in Bognor Regis, mid-way between its junctions with The Esplanade and Belmont Street.

**(Bognor Regis, Clarence Road Amendment) Order 2024**

**Statement of Reasons for Proposing to Make the Order**

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will install a loading bay for any vehicle at any time on the western side of Clarence Road in Bognor Regis, mid-way between its junctions with The Esplanade and Belmont Street.

Planning consent has been granted for the construction of a new hotel on the site of the former fire station located on the western side of Clarence Road. To accommodate the expected frequent deliveries to the new building a layby for loading will be constructed on the western side of the road. This will allow deliveries to be made safely without obstructing traffic on Clarence Road. The proposed Order formalises this arrangement to prevent the new layby being obstructed by general parking.

The new order is therefore proposed to facilitate the passage of traffic.

The attached drawings, numbered SZ9399SES and SZ9398NEN show the lengths of roads affected by the proposed order.






