NOTICE is hereby given that West Sussex County Council propose to make a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to extend the length of prohibition of waiting at all times (double yellow lines) on the southern side of Byron Close, east of St Marys Drive, eastwards by a distance of 40metres.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to extend the length of prohibition of waiting at all times (double yellow lines) on the southern side of Byron Close, east of St Marys Drive, eastwards by a distance of 40metres.

Byron Close is a residential cul-de-sac in close proximity to Three Bridges railway station and on the periphery of a Controlled Parking Zone. This creates a high demand for on-street parking with railway commuters and residents from the CPZ vying for spaces with residents. Current on-street parking practice causes localised obstruction and access difficulties and, on occasion Sussex Police have been called to deal with obstructive parking. The Council received a request to address this issue.

The road has a narrow width and is an access road to residential properties. Vehicles are frequently parking on the footways and without consideration for residential access. This can obstruct forward visibility for other drivers and pedestrians.

To alleviate the problem, it is proposed to introduce a TRO to prohibit parking by extending a length of double yellow lines on the southern side of Byron Close. The extended double yellow lines aim to better manage parking and deter obstructive parking practices. This will ensure that all road users will have better forward visibility.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenity of the area through which the road runs.

The "West Sussex County Council (Crawley Borough) (Parking Places and Traffic Regulation) (Consolidation) Order 2010" is hereby amended by the deletion from it of the plan specified in the First Schedule to this Order and the substitution into it of the plan attached in the Second Schedule to this Order.




