NOTICE is hereby given that West Sussex County Council proposes to make a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to make the following amendments to the existing parking/waiting restrictions in the Horsham Controlled Parking Zone:

- (i) introduce a length of no waiting at any time restriction (double yellow lines) on the east side of Chesworth Gardens north-east of its junction with Chesworth Lane; and
- (ii) extend the permit holders parking controls in the designated parking bays in St Christophers Close to apply 9.00am to 5.00pm Monday to Saturday.

The consultation for this proposal will start on 17 October 2024 and, AT THAT TIME, full details of the proposals in this Notice can be viewed on the TRO pages of the [West Sussex County Council website](#). The website includes a response form for comments or objections.

Paper copies of documents will not be available to view in council offices or libraries. People without access to a computer who wish to view details of the scheme should telephone the West Sussex County Council Contact Centre on 01243 642105 to receive the documents by post.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to make the following amendments to the existing parking/waiting restrictions in the Horsham Controlled Parking Zone:

- (i) introduce a length of no waiting at any time restriction (double yellow lines) on the east side of Chesworth Gardens north-east of its junction with Chesworth Lane; and
- (ii) extend the permit holders parking controls in the designated parking bays in St Christophers Close to apply 9.00am to 5.00pm Monday to Saturday.

As part of the on-going maintenance of the CPZ in Horsham the parking and waiting restrictions are kept under review. A couple of minor amendments are proposed in roads in the CPZ.

In Chesworth Gardens it is proposed to replace parking bays north-east of the junction with Chesworth Lane with a length of double yellow lines. Vehicles parked in these bays are obstructing access for refuse lorries and larger vehicles when turning into the cul-de-sac forcing them to mount the verge to pass.

In St Christophers Close it is proposed to extend the permit holders parking controls to apply 9.00am to 5.00pm Monday to Saturday and to only allow 1 hour limited waiting for non-permit holders in all the designated parking bays. The parking restriction will deter non-residents from parking all day and in doing so improve on-street parking capacity for residents and their visitors.

This Order is proposed for facilitating the passage on the road or any other road of any class of traffic, and for preserving or improving the amenity of the area through which the road runs.

The "West Sussex County Council (Horsham District) (Parking Places and Traffic Regulation) (Consolidation No. 2) Order 2006" is hereby amended by the deletion from it of the plans in the First Schedule to this Order and the substitution into it of the plans attached in the Second Schedule to this Order.










